# RESOLUTION

Expressing opposition to the European Commission interpretive notice regarding labeling Israeli products and goods manufactured in the West Bank and other areas, as such actions undermine efforts to achieve a negotiated Israeli-Palestinian peace process.

Whereas the United States supports a negotiated solution to the Israeli-Palestinian conflict resulting in two states, a democratic, Jewish State of Israel and a viable, democratic, Palestinian state, living side-by-side in peace, security, and mutual recognition;

Whereas a true and lasting peace between Israel and the Palestinians can only be established through direct negotiations regarding outstanding issues between Israel and the recognized leadership of the Palestinian people, the Palestinian Authority;

Whereas a true and lasting peace between Israel and the Palestinians is in the national security interests of the United States and necessary to ensure the safety and security of Israel;

Whereas the anti-Israel Boycott, Divestment, and Sanctions (BDS) movement has called on the European Commission to go beyond labeling guidelines and implement a ban on the import of products of Israeli companies that operate in the West Bank and other areas;

Whereas politically motivated acts of boycott, divestment from, and sanctions against Israel represent a concerted effort to extract concessions from Israel outside of direct negotiations between the Israelis and Palestinians, and undermines efforts to achieve a negotiated two-state solution;

Whereas the United States has long opposed efforts to impose solutions to the Israeli-Palestinian conflict outside of direct negotiations between the two parties;

Whereas the United States has historically been at the forefront of combatting economic pressure against Israel and has enacted legislation to counter both the Arab League Boycott of Israel and the BDS movement;

Whereas one-sided actions, such as singling out Israeli products, serves to encourage and prompt consumers to boycott Israeli products and goods manufactured in the West Bank and other areas;

Whereas U.S. law (P.L. 114-26) states that the United States should discourage potential trading partners from adopting policies to limit trade or investment relations with Israel when negotiating the Transatlantic Trade and Investment Partnership with European countries;

Whereas the United States and the European Union have historically worked in coordination to bring an end to the Israeli-Palestinian conflict; and

Whereas multiple United States State legislatures have enacted measures to confront politically motivated acts of boycott, divestment from, and sanctions against Israel including Tennessee, Indiana, Illinois, South Carolina, and New York: Now, therefore, be it

1       *Resolved*, That the House of Representatives—

2               (1) expresses opposition to the European Com-  
3       mission interpretive notice regarding labeling Israeli  
4       products and goods manufactured in the West Bank  
5       and other areas, as such actions undermine efforts  
6       to achieve a negotiated Israeli-Palestinian peace  
7       process

8               (2) opposes politically motivated acts of boycott,  
9       divestment from, and sanctions against Israel or  
10       Israeli-controlled territory;

11              (3) calls upon the European Commission, the  
12       Council of the European Union, and the European  
13       Parliament to oppose any boycott, divestment, or  
14       sanctions initiatives aimed at singling out Israel, to  
15       refrain from actions counterproductive to resolving

1 the Israeli-Palestinian conflict, and to work on  
2 bringing the parties back to the negotiating table;

3 (4) encourages European Union member states  
4 to exert prudence in the implementation of the Eu-  
5 ropean Union labeling guidelines;

6 (5) urges the Administration to increase the use  
7 of its voice, vote, and influence in international orga-  
8 nizations and other appropriate international forums  
9 to actively oppose political motivated acts of boycott,  
10 divestment from, and sanctions against Israel;

11 (6) supports efforts by United States' State leg-  
12 islatures to enact measures that oppose politically  
13 motivated acts of boycott, divestment from, and  
14 sanctions against Israel; and

15 (7) reaffirms its strong support for a negotiated  
16 solution to the Israeli-Palestinian conflict resulting  
17 in two states, a democratic, Jewish State of Israel  
18 and a viable, democratic, Palestinian state, living  
19 side-by-side in peace, security, and mutual recogni-  
20 tion.
